### THE CONTRACT ABOUT COOPERATION

Federal State Educational Budget Institution of Higher Education «The Ulianov Chuvash State University», further called the Chuvash State University from the name of the rector Aleksandrov Andrei Yurievich operating on the basis of the Charter, on one hand and Hawler Medical University, in the person of President Dara Omer Meran on the other hand, have concluded the present Contract about Cooperation as follows.

### 1. The Contract purpose

The purpose of the present Contract is the cooperation establishment between Hawler Medical University and the Chuvash State University in the field of education, scientific researches.

## 2. The Contract subject

The basic directions of joint activity concern:

- 2.1 Using of scientifically-methodical and innovative potentials Hawler Medical University and the Chuvash State University in perspective directions of scientific and educational activity.
- 2.2 The exchange of teachers, scientists and employees under short-term and intermediate term programs.
- 2.3 Carrying out of joint scientific researches.
- 2.4 Drawing up and transferring of manuals and methodical materials.
- 2.5 The publications exchange in all the volume of cooperation questions.
- 2.6 The Improvement of executives, carrying out of teachers, young scientists and students of the Chuvash state university training on base of Hawler Medical University, and training of teachers, young scientists and students of Hawler Medical University - on the basis of the Chuvash State University.
- 2.7 Joint carrying out of seminars, conferences, symposiums etc.

#### 3. Duties of the Parties

The Parties take up the following long-term obligations:

- 3.1. To organize scientific, scientifically-methodical and educational directions of joint activity.
- 3.2. To carry out an exchange of pedagogical and research work experience actively attracting the leading professors and experts of the Chuvash State University and Hawler Medical University.
- 3.3. To carry out the exchange of scientific publications, textbooks, manuals, methodical grants, plans and programs, university periodicals, the computer programs.
- 3.4. To exchange an operational experience, including within the limits the improvement of teacher's professional skill using new information technologies in teaching and remote training.
- 3.5. To develop new approaches to the organizing of the students scientific work together.
- 3.6. To communicate regularly about new receipts of the libraries literature funds.
- 3.7. To direct on target training of students, post-graduate students and doctoral students.
- 3.8. To develop business partnership on the basis of equality and mutual benefit.
- 3.9. Not to disclose the confidential information.
- 3.10. Not to cause the property damage of the Parties.

# 4. Period of the Contract Validity and Other Conditions

- 4.1. The present Contract comes into force from the moment of its signing and operates without term restriction while one of contracting parties will not notify other party about the intention to terminate the present Contract or desire to change its conditions.
- 4.2. In case of intention about Contract cancellation unilaterally the Party notifies on it other Party not less, than for 30 days.
- 4.3. Cancellation of the Contract does not attract cessation of work under earlier coordinated and confirmed programs up to their full end.
- 4.4. The contract can be terminated or its separate articles are changed under the agreement of parties with drawing up of the corresponding additional agreement operating before the expiry of the term of action of the present Contract. Thus specified additional agreements are the Contract integral part.

#### 5. Other Conditions

- 5.1 Each party carries out cooperation within the limits of the present Contract according to the current legislation of the Russian Federation and the Republic of Iraq.
- 5.2 In connection with it's signing the present Contract does not impose any financial obligations towards the Parties. The conditions of cooperation realization within the limits of the present Contract, including financial mutual relations, are discussed by the parties with registration of separate agreements which are an integral part of the present Contract.

#### 6. Final Provisions

6.1 The present Contract is made and signed in duplicate (one - in Russian and one - in English), having an equal validity, and is received in one copy by each of the Parties.
